## Benjamin Promoted to Vice President, Corporate Development and Planning for A&B

Benjamin, 39, was born and raised in Michigan and graduated from the University of Michigan with a bachelor's degree in economics. Subsequently, he earned a master's degree in business administration from Harvard Business School. A Hawaii resident since 1992, Benjamin was selected as a Pacific Century Fellow, participating in the program in its inaugural year.

Benjamin serves on the International Lay Review Committee of the Juvenile Diabetes Research Foundation (JDRF), a panel that allocates roughly \$100 million per year to diabetes research worldwide. He co-chairs a support group for children with diabetes in Hawaii, and is past president of the local chapter of JDRF.
