Douglas Pasquale Joins Alexander & Baldwin Board

HONOLULU--(BUSINESS WIRE)--April 28, 2005--Douglas M. Pasquale was today elected to the board of directors by the shareholders of Alexander & Baldwin, Inc. (Nasdaq:ALEX), announced A&B Chairman of the Board Charles M. Stockholm, bringing with him extensive experience in the fields of real estate and finance, and executive leadership for large, national companies. Prior to that, he was with Richfield Hospitality Service, Inc. for a dozen years, starting as vice-president and assuming roles of increasing responsibility, including chief financial officer and finally president and CEO of their Regal Hotels International-North America division. Pasquale also was chief financial officer for Foxley & Company, one of the nation's largest privately held agribusiness companies.

"Doug's experience with large national companies and in many areas relevant to A&B will make him a valuable contributor to A&B's future course of growth," added Allen Doane, A&B president, chief executive officer and board member. "I look forward to working closely with him and, as always, the other members of the A&B board."

Pasquale becomes the tenth member of the A&B board, six of whom are residents of Hawaii. He also will serve on the board of A&B's subsidiary, Matson Navigation Company, Inc.

Pasquale earned both a master's degree in business administration and a bachelor's degree in business from the University of Colorado at Boulder.

Pasquale is a member of the executive board of the American Senior Housing Association and, in addition to joining the A&B board, he currently serves on the corporate board of Nationwide Health Properties.
